- 1. The October 3-4 AKC Hunt Test at the Kinzalow Farm in Spring City had 125 entries as compared to 344 entries at the May 23-24 Hunt Test. The May test resulted in a gain of \$7000.00 but the October test had an \$800.00 loss.
- 2. The board officially thanked professional Jody Ware for his free-to-members problem solving training seminar on November 14-15 at the Kinzalow Farm. The club paid his travel expenses and gave him a gift certificate. Thirty members attended on Saturday and 20 members on Sunday. Jody worked individually with each owner and their retrievers on land and water. Using ducks and shotguns to address problems Jody did not sit down either day from 8 AM to 3 PM. He was assisted by members Brian Caldwell and Doug Nelson.
- 3. The board clarified the disputed field use at the Kinzalow Farm. The agreement of August 15, 2009, between the Hale Bopp Hunt Club and ETRC restricts the club training use to the two adjacent fields at the front pond. ETRC cannot train in the "cedar tree field" but may drive through to reach the east field.
- 4. The date of May 29-30, 2010, has been approved by TWRA and AKC to hold the Memorial Day AKC Hunt Test at the Hiwassee Refuge, Birchwood, TN. Judges are being obtained.
- 5. Discussion was held on the invitation of Chad Baker and Mark Chase for ETRC to join them in forming a new AKC field trial club in Upper East Tennessee. The board agreed to help them in any way the club could. The AKC procedures to form a new club can be lengthy, complex and require legal and accounting assistance. An AKC Manual "How to Form an AKC Accredited Dog Club" can be printed off from the AKC website Page "How to Form a Club".
- 6. The club will comply with the request of AKC to update our home state non-profit incorporation License. Also, to comply with Internal Revenue Service request to file Form 990 for non-profit Clubs with receipts over \$25,000 annually.
