October 29-30 CANCELLED The Fall AKC Hunt Test was cancelled due to lack of entries three days before the closing date of October 19. Only 18 total entries had been received by Entry Express compared to three other AKC Hunt Test Clubs entries, two of these were doubleheaders, who had acquired 305 entries in KY, 302 entries in MO/KY, and 199 in Alabama at their closings. All three Hunt Tests and ETRC were within 300 miles of each other. The board could
