### New AKC Hunt Test Rules and Regulations –Effective January 1, 2012

In a AKC Board of Directors meeting (not a Delegate meeting) in August, 2011 a significant number of AKC Hunt Test Rules and Regulations were approved to take effect January 1, 2012. These new rules effect Junior Hunter setups, Master and Senior walkups, Prospective judges vetting of qualifications (by event giving club) is no longer AKC responsibility. The new rules are posted on ETRC website (etrclub.org) under F.Y.I. (For Your Information). One of the Master judges must have qualified a Master dog five times to be eligible to co-judge in a Master event. The new rules are being discussed on the Retriever Training.net website.
