Master National 2013—Flint Oak Hunting Preserve—Fall River, Kansas September 19

The Master National 2013 event will begin at least a seven-day hunt test on Saturday, September 21. The final count of qualifiers nationwide on July 31, 2013 was 828 requiring at least four splits. Last year 710 dogs entered with 900 qualified. The event will end on September 29. Residents of the Kansas area are warning handlers of the grounds being covered with flint (rock) requiring tough retriever pads to stay healthy. The Sunflower Retriever Club is the host club. New AKC Hunt Test Rules and Regulations—Senior Tests - Judges Retaining Score Sheets

<u>News Bulletin from Performance Events Dept to: Clubs Licensed to Hold Retriever Hunting Tests—Effective</u> September 1, 2013. Subject: Walk-ups in Senior Level Test & Judges Completing/Retaining Score Sheets

This is to inform your club of two recent changes to the Retriever Hunting Test Regulations. The changes were recommended by the Retriever Hunting Test Advisory Committee. The Performance Events Dept agrees with the recommendations. They are meant to clarify and bring greater consistency to the sport.

<u>Walk-ups in the Senior Level Test:</u> Chapter 5, Section 6. There is a sentence in this section that states—"There shall be at least one diversion shot and at least one of hunting situations should include a walk-up" The intent is that a walk-up is required in the Senior Hunter test. However, there are some judges that interpret "should" as meaning it is not required. Therefore, the word "should" has been changed to "shall". The new sentence reads—"There shall be at least one diversion shot and at least one of hunting situations should a walk-up."

<u>Judges Completing and Retaining Score Sheets</u>: It has always been the intent that the score sheet be completed as documentation of a dog's performance. A few judges claim they do not need to score a dog's performance, rather they can remember if a dog deserves to qualify. This is not good practice. Further, occasionally questions arise regarding test results. The ability to refer back to the score sheets can aid in resolving these questions. Therefore, wording has been added that requires judges to complete the score for each ability being evaluated in each series and to retain the score sheets for at least 60 days following the completion of the test. This is an addition to Chapter 2, Section 1. A new paragraph in this section will read as follows-A judge must record on the *Evaluation Form* (score sheet) the score assigned for each ability being evaluated in each series. A judge may not simply note that the dog qualified or did not qualify. The form must be completed with the dog's numeric scores prior to determining if the dog qualified. The *Evaluation Form* must be retained by the judge for a least 60 days following the end of the test. Both these changes become effective September 1, 2013.
