



UPCOMING 2009 ETRC EVENTS

April 11 ETRC 2nd Spring Club Trial, Chota Waterfowl Refuge, Citico Road, Vonore, TN. Club trial begins at 8 AM. Junior, Senior, Master, Singles Classic, and Puppy stakes. E-collars not allowed. Ducks will be thrown and birdboys hired. \$10.00 per dog per event, puppy stakes \$5.00 . Stake entry and completions will count toward annual Gun Dog and Puppy of the Year awards. The club has a TWRA permit to use the refuge all day. Bring your lunch, water, and a chair. **DIRECTIONS:** Go 20 miles south of Maryville, TN on Hwy 411 to Vonore, TN. Turn at Hardee's onto Hwy 360 and go 8.2 miles to a split intersection. Take the left split onto Citico Road. Go five miles to Chota Refuge sign on left.

May 23-24 AKC Spring Hunt Test, Hiwassee Refuge, Blythes Ferry WMA, Birchwood, TN. Memorial Day weekend. Entries are by online using Entry Express (www.entryexpress.net) or a paper premium from Entry Express at (501) 255-0831. Judges have been obtained and approved by AKC. The event is taking entries. Deadline to enter is May 13. Tests will be a split Master, and a double Senior and Junior stakes. Member participation and teamwork will be needed to hold a successful event. The main WMA rule is "NO DRIVING IN FIELDS". TWRA will allow equipment movement by ATV's as long as they stay at the edge of the fields.
