ETRC Club Trial May 14, 2016 in Sevierville

Our second Club Trial of the year will be Saturday, May 14, with setup and sign-ups beginning at 8 a.m. It will be held at Chuck Atchley's beautiful Revilo Farm, Sevierville, TN. Detailed directions are given below.

Events: Singles Classic, Master, Senior, Junior, Puppy Stakes (under 1 yr). Entry Fee: \$10.00 each stake per dog (dokkens), Puppy Stakes (bumpers) \$5.00 (1 PM). **MEMBERS ONLY**. If you haven't yet renewed for 2016 or want to join for the first time, forms and people to take your membership fee (\$25 for the year) will be available before you sign up. NOTE: we are using dokkens because our duck supply from last spring's test is rancid and pretty much unusable.

No E-collars allowed. All dogs must be on leash when out of vehicle unless running tests. Bring your retriever, a chair, your lunch, and water. Tee shirts, hats, and other club 'stuff' will be available for sale.

WEATHER CANCELLATION POLICY: We will send out an email on Friday night if the weather is such that we are going to have to cancel the trial.

DIRECTIONS: Take II-40 to Exit 407, Sevierville, TN. Go south on Hwy 66 towards Sevierville. Go approximately three miles across the French Broad River bridge to Hwy 338 (Boyds Creek Hwy). Turn right and stay on Boyd's Creek for 2.5 miles to Revilo Farm on the right. Turn right at large Revilo Farm sign. Headquarters at picnic area.

Report on the April 9, 2016 Club Trial in Sweetwater

- Jim Pearce for bringing the club's new smaller trailer over.
- Lois Luthenauer, who ordered and collected the new tee shirts and brought over the ducks.
- Roberta Williams and Karen Edwards, who ran the table.
- Everyone who threw bumpers and acted as bird boys.

Signups and setups began at 8:00 a.m., and the action was underway by 9:30 a.m. The weather was brilliantly sunny but chilly and windy, which also added to the fun!

The Singles Classic was run first and was comprised of two long land marks. Master and Senior were run on the same set-up at the technical pond near the back of the property, and involved both land and water work. For Master, there was a land triple, one water/land blind and a land blind. The blinds were tight behind the marks which created a terrific challenge for the dogs! The senior setup was a double (the two outside marks) and a blind in an easier location. Junior and Advanced Junior were run on the same setup down near the small pond, with the difference being that Advanced Junior used a double mark and an honor. The puppy stakes were run up near the barn that served as Headquarters and were land marks only.

Results:

Singles Classic: 16 dogs entered, 15 passed. Breeds included 12 labradors and 3 goldens. First place: Woodie (CLM) and Lois Luthenauer Second place: Cash (CLM) and Haley O'Neal Third place: Susie (CLF) and Lois Luthenauer Fourth place: Panda (GRF) and Jim Pearce

Master Test: 9 dogs entered (7 labs, 2 goldens), 4 passed (all labs). The rest had troubles with all the delicious scents from the rotten ducks in front of the blinds! Passing were: Shine and Alan Bruhin; Sonny and Fay Norwood; Sniper and Ritchie Grigsby; and Woodie and Lois Luthenauer.

Senior Test: 3 entered (all labs), 2 passed. Passing were Aspen with Ben Dorton and Cash with Haley O'Neal..

Advanced Junior Test: 4 entered (3 labs and a mini poodle), 1 passed. Passing was Nina (poodle) with Beth White.

Club Test Results, April 9, 2016 Continued

Junior Test: 3 entered (all labs), none passed.

Puppies: 4 entered and 3 puppies ran, ranging in age from 6 weeks (!) to 8 months. 1st. place, Cooper and Ben Dorton (Lab); 2nd, Dixie and Tracy Heard (Boykin Spaniel); and 3rd, Polly with Lois Luthenauer (Lab).

The Club took in \$370 in entry fees, \$5 in donations (thank you Adam Smelcer!) and \$175 in tee shirt/hat sales. In addition, two new member/families joined and an old member renewed. There were no expenses.


Final Thoughts:

Overall, this was a good event. It would have been improved if we would have hired a few outside birdboys rather than have to rotate people through the blinds. Also, next time we will combine all the stakes (other than Singles Classic and Puppy) into a single set-up, for greater efficiency for people who are running dogs in multiple levels, and so we can all be together in the same spot for more camaraderie. Finally, the ducks were really bad – leftovers from last spring's hunt test and frozen/thawed more than once. It posed a real problem for the younger dogs (who thought they were fine for rolling in but were not as enthusiastic about carrying them around in their mouths). We need to consider investing in some dokkens or buying fresh ducks for these events. Also, we need to put a few more things in our new small trailer – a couple of signs to make it easier to find the event; some blind stakes or tape so we don't have to rely on using people's private supplies; and a marshal's box with duck calls etc.

2016 Spring Hunt Test—Important Information

It's almost here! We are looking forward to a great test at the Hiwassee Refuge May 28 and 29, with set-up on Friday the 27th. The official motel is the nearby Best Western in Dayton, TN, phone (423) 775-6560. Call right away for reservations as there are local fishing tournaments on the same weekend. Be sure to specify that you are coming to the ETRC Hunt Test as we do have a small block of rooms reserved. This is a pet friendly motel.

Entries for Master are limited to 120 dogs in two flights, Master A and Master B. The event will open on Wednesday, May 4 at 8 p.m. CENTRAL time for entries. For the first 24 hours, only entries from the ETRC worker pool may enter. ETRC will be allowed to designate up to 15% of the Master entries (18 dogs total) to receive a code number sent from Entry Express to the Hunt Test Secretary. First contact Lois Luthenauer (mountainLO717@gmail.com) or Michael Evans (Fowl_Mouth_K9@aol.com) to sign up for at least 4 hours of work at the test, then contact Test secretary Roberta Williams (sharphlw@usit.net or 1-865-680-1388) before May 4 to request your code.

We need people to help set up on Friday, move equipment during the test, serve as Marshals, help with the Judges Dinner Friday night, and clean up on Sunday. Fun for everyone! All people who work will be signed up automatically for the workers raffle — tee shirts, hats, a wool jacket, and more! Plus workers are invited to stay for the Judges' dinner at the clubhouse Friday night.

Our test will be a qualifying test for the new Master Amateur national hunt test that will be coming up in spring 2017, as well as for the Master National Hunt Test.

Directions to Hiwassee Refuge, Birchwood, TN:

<u>From I-75</u>: Take I-75 South to Cleveland, TN, Exit 27. Take a right off the ramp onto Paul Huff Parkway. Go one mile to redlight and take a right turn onto Hwy 60. Go 13 miles through Birchwood, TN. Look for cemetery on right and turn right on Shadden Road. Go 1/2 mile to large Hiwassee Refuge sign. Take a right on Blythe Ferry Road into the WMA.

<u>From I-40</u>: Take I-40 West to Rockwood, TN, Exit 347. Turn onto Hwy 27 South to Dayton, TN. In Dayton take Hwy 60 South ten miles to Hiwassee Refuge sign on left. Watch for Orange ETRC goose signs into WMA.

Deadline Extended for the 2016 Luthenauer Young Handler's Program

ETRC is inaugurating a new program designed to benefit young ETRC members. Named in honor of long-time club member, past president, and enthusiastic sportsman Kevin Luthenauer, and funded largely via donations from his family and friends, this program will support kids up to college graduation who want to participate in retriever sports. Key points include:

- 1. Free admission to all ETRC events including club trials, ETRC-sponsored seminars, etc.
- 2. Refunded entry fees for up to six AKC Hunt tests during the club year (March 1-Feb 28).
- 3. Invitation to a club-sponsored Junior Handlers Seminar, presented by one of ETRC's pros or a senior handler.
- 4. Carpooling assistance as needed to get to club events.
- 5. Volunteer assistance at various events is required, a minimum of 8 hours a year.
- 6. An end-of-the-year ETRC Young Handler of the Year Award. Points may be gained from participation in ETRC events including training sessions, AKC Hunt Tests, and volunteer activities.

IF YOU ARE A FULL TIME STUDENT in an elementary, middle, high school or 2-or-4 year college program and are under 23 years of age, **AND** if you are either an individual member of ETRC or part of an ETRC Family membership, you are eligible to apply for this program! To apply: submit an essay of at least one page in length, describing why you are interested in pursuing retriever sports and how the retriever sports impacts your everyday life. This essay may be submitted via email or snail mail to Lois Luthenauer, the 2016 Youth Program Coordinator, for consideration by the ETRC Board of Directors. Board Meeting Summary, April 9, 2016

The ETRC Board of Directors met at the barn on the Darryl and Sharon Miller farm in Sweetwater following the conclusion of the Club Trial on April 9, 2016. The meeting was called to order by President Lois Luthenauer. All Board members were present except Ron Burger, Michele Fletcher, Diane Fyfe. Minutes available for review on the website since March 22, 2016 were approved as posted. The Treasurer reported that the current bank balance (after paying for the new duck driers) is \$11,378.20 after purchasing new tee shirts and hats with only one bill outstanding (\$94 for website work, first quarter).

Website Changes: Routine updates on hunt test information; posted March minutes, posted April Newsletter.

Membership: Anyone who has not renewed by June 1 will be dropped from the club rolls and will not receive further emails and newsletters. Karen Edwards reported that so far, 2016 membership stands at 44 families, with 21 who have not yet rejoined for 2016.

<u>Spring Club Trials</u>. The first Club Trial was held today. See results on page 3. The next Club Trial is scheduled for May 14 at the Chuck Atchley farm (Revilo) in Sevierville. Plans were discussed and finalized for this event; Karen Edwards will send out an email either the night before or first thing in the morning if we are forced to cancel because of weather.

Spring AKC Hunt Test. Plans are well underway. Entries will be open May 4-16. Anyone who wants to rent one of the motel rooms needs to do so quickly as there are fishing tournaments in the area the same weekend.

Fall AKC Hunt Test. The approved AKC dates for this test are October 22-23. We have located new grounds for this test at the Lucky 7 Ranch near Sweetwater, and are in the process of getting AKC/TWRA approval of the grounds. Judges selection is underway.

<u>The Luthenauer Young Handler Program</u>. The deadline for receipt of applications has been extended until May 31. In the meantime, we are going to be getting a \$500 donation (our land use fees for the Lucky 7 Ranch, which owner Ken Campbell is donating back to us for this program) so it will be a shame if we have all this money and no one to spend it on. Board Meeting Summary, April 18, 2016

The ETRC Board of Directors met at the Pegasus Technologies conference room in Lenoir City. The meeting was called to order at 7:15 p.m. by President Lois Luthenauer. Present were Lois, Michele Fletcher, Karen Edwards, Roberta Williams, Michael Evans, Tom Gibson, and Diane Fyfe. Minutes of the last meeting were available for review on the website since April 13, 2016 and were formally approved as posted. The Treasurer reported that the current bank balance is \$11,914.20 will no bills outstanding.

Website Changes: Posted April 9 minutes.

Membership: Anyone who has not renewed by June 1 will be dropped from the club rolls and will not receive further emails and newsletters. Karen Edwards reported that so far, 2016 membership stands at 44 families, with 21 who have not yet rejoined for 2016.

Spring Club Trials. The next Club Trial is scheduled for May 14 at the Chuck Atchley farm (Revilo) in Sevierville. Plans were discussed and finalized for this event, including the use and purchase of 30 dokkens instead of rotten ducks. Karen Edwards will send out an email either the night before or first thing in the morning if we are forced to cancel because of weather.

Spring AKC Hunt Test. Still working on filling worker slots. Entries will be open May 4-16; workers can get a code for early entry to make sure you can get one of the scarce Master slots.

<u>Fall AKC Hunt Test</u>. The approved AKC dates for this test are October 22-23. TWRA has notified us that we can use Hiwassee the weekend of November 4; the board discussed and voted to explore with AKC whether these dates were available and if so, have the test there. If not, we will continue planning for use of the Lucky 7 Ranch near Sweetwater, with either a single flight Master, or using another nearby farm for a second Master flight. Judges selection is pending a final decision on which date/location we will be using. [EDITOR'S NOTE 4//28/16: AKC will not approve us moving to the November date as it conflicts with Fall Line's test, so we will be staying with the October 22-23 dates after all, and working to get approval for use of Lucky 7 /Dogtown properties.]

<u>Raffle</u>: Mike and Donna Smith reported they have received some donations but more are needed and there are no big items that would be enticing for selling raffle tickets. They have contacted 13 companies and only three responded positively. We discussed two options: adding \$500 from the treasury to have significant first, second and third prizes; or canceling the raffle and using the donated items for a workers-only raffle. After some discussion, the Board decided to use the second option, and discontinue planning for an open ticket-sale type of raffle.

Summer Training Seminar: We are hoping to get Jody Ware back for a full-day training seminar this summer, possibly at the Fyfe / Fletcher farm near Pikeville, TN again — Lois will contact the Ware's to see if either June 18 or June 25 will work for them. If not, we will explore other dates/options.

Summer Picnic: Ken Campbell had tentatively offered use of Lucky 7 for our annual picnic/business meeting. Lois will contact him to see if this is OK and to firm up a date. First choice is August 20. We would like to have this combined with a field trial / training demo by John Broucek and Brady Collins if possible.

The meeting was adjourned at 9:10 p.m. The next meeting will be held after the Club Trial on May 14 strictly to discuss plans for the hunt test.
